**Second Meeting of the States Parties to the Treaty on the Prohibition of Nuclear Weapons**

Mr President,  
Prime Minister,

We are writing to you as a group of organisations in France and the United Kingdom, from varying backgrounds, but each with a deep concern at the proliferation and continued development of nuclear weapons in an increasingly polarised and fragmented world.

We welcomed the adoption and entry into force of the Treaty on the Prohibition of Nuclear Weapons (TPNW) which has now been signed by almost half of all countries. We are convinced that this treaty represents the best opportunity for a long-term solution to the dangers posed by nuclear weapons.

By contrast, we note that 53 years since its entry into force, the Non-Proliferation Treaty (NPT) has not, despite its stated aims, resulted in any measures of unilateral or multilateral disarmament. Instead, there has been an increase in both the number of nuclear-armed states and the level of risk, as evidenced most recently by the current war in Ukraine and the escalating conflict in the Middle East. The failures of the Review Conferences of the States Parties to the NPT in 2015 then again in 2022 exemplify the current situation of stagnation or worse.

We are aware that France and the UK have both stated their opposition to the TPNW publicly and that, as recently as March this year, in a joint leaders' declaration, you reiterated that opposition as a common position between you. We would urge you to reconsider that position. Our belief is that the majority of French and British citizens support our countries' engaging with the TPNW process<sup>1</sup>.

We are convinced that, of the nine nuclear-armed States, France and the United Kingdom are by far the best placed to initiate momentum towards disarmament – a disarmament which humanity so badly needs, so that resources and energy can be harnessed to the challenges of poverty and exclusion, climate change, and the collapse of biodiversity rather than the maintenance and development of nuclear arsenals, the possession and use of which could have catastrophic consequences.

In that light, we make a solemn request that you send representatives to observe the proceedings of the 2<sup>nd</sup> meeting of States Parties of the TPNW in New York from the 27<sup>th</sup> November to the 1<sup>st</sup> December.

Attendance at the meeting as non-signatory observers would give both governments the opportunity to listen, understand and respond to issues raised by those states engaged in the process.

In particular, attendance would provide the opportunity to repair the historic and ongoing harm that has been caused by nuclear weapons testing by both countries. You will be aware that Articles 6 and 7 of the TPNW establish the first international legal framework through which the issue of that harm can be addressed.

On 27<sup>th</sup> October of this year, the United Kingdom and France were two of just four states to vote against a resolution tabled by Kazakhstan and Kiribati Islands on 'Addressing the legacy of nuclear weapons: providing victim assistance and environmental remediation to those Member States affected by the use or testing of nuclear weapons'. This put the UK and France alongside Russia and North Korea as the only states to vote against the resolution.

Sending observers to the States Parties meeting would be a step towards recognising the responsibility both countries have by virtue of their nuclear armed status, and towards addressing the consequences of their nuclear weapon testing programmes.
